May/Ver/2/May16

- a) Any citizen of India or his nominees whether born or not born in India but holding Indian Citizenship and who has attained the age of 18 years and is not of unsound mind or has not become Insolvent nor incapable of taking decisions nor has in any way lost his rights to enter into contractual liabilities nor has not been convicted in a heinous crime or Fraud nor has lost his rights to give consent AND is involved Directly or Indirectly in the Distribution / Promotion / Sales/ Servicing / Consultancy of Financial Products and not restricted to The Mutual Fund Industry in India can become the member of the Society.
- b) The Nominees and Assign whether Minor or Major of an Individual or a proprietorships or HUF or Partnership or any legal entity who are Citizens of India after the death of an Individual who was a citizen of India and was aged 18 years of age and who was/were Involved Directly or Indirectly in Distribution / Promotion / Sales/Servicing / Consultancy of Financial Products and not restricted to the Mutual Fund Industry in India and are in any way are entitled to get or are getting Benefited financially or non-financially for the work done by that Individual or Entity in his Lifetime can become the members of the Society either in their own capacity or through their legal guardians as per rules of membership defined herein or any resolution passed in the Governing Body.
- c) The Governing body in exceptional cases and looking in to the benefit of the Society shall reserve the right for admission of any member into the society on Honorary basis or Special members or any other basis as may be decided by the Governing Body .
- d) The Governing body shall take the decision to admit or not admit the applicant as a member of AMDWA ( ALL MUTUAL FUND DISTRIBUTORS WELFARE ASSOCIATION). The decision of the Governing Body on the application of membership shall be final and the Governing Body shall not be bound to assign any reason for its decision.
